## Senior's Field Trial?

We will be discussing the possibility of a Senior's Division for future field trials. On the face of it, this would seem to me to be long over due not just for our trials but for other organizations also. There may be some organizations that are already doing this, of which, I am not aware.

Think of it. You have a proven dog that is a winner that may have lost a step with age and so gets left in the kennel while you compete with the younger dogs. Older dogs are already trained and all you have to do is work with them just a little and they are ready to compete with the same determination that they have always shown.

The minimum age is up for discussion. There could also be a minimum age for the handler and shooter. To me, 10 years young would give these older pups a chance to compete for another 2 to 5 years. Also, Seniors could still compete in the All Age Dog Division.

The few people that I have talked to have been mostly positive. Jake is all for it. He will be 13 by the time next season rolls around and hopefully he could compete in both divisions.

His dog Native Tango won the National Field Trial at Grand Junction, Tennessee. Strawdog won the Region 16 several times. Dr. Kyendall, a veterinarian, also passed along to our attending members valuable tips on dog care including feeding and health care.

At our April meeting, we had a last minute speaker named **Danny White** from Circle W Preserve in Heflin, AL. I was sorry James Frost was not in attendance, because Danny was running a field trial the following Saturday, using rules similar to that of which I have heard James speak. Danny spoke of his first trial in Horns Valley and of some of the champion dogs he has trained. He also spoke about some of the methods he uses to train his dogs.

Mike Barlow and I attended a field trial in Hatchachubbee, AL. The field trial was sponsored by the **East Alabama Field Trial Association**. The trial was a 4-day event that was held on the lands where Collier Smith trains his dogs. They were very friendly to us and even lent us two horses to ride in the gallery to view the dogs as they covered miles of beautiful quail country. While

inspecting the grounds, kennels and office, we saw an old newspaper clipping about Dr. Kyendall framed on the wall.

**Les Lockridge** will be our speaker for our May 13th meeting. Les is a Certified Master Shooter in the field of Sporting Clays.
