### We will also be competing this year in the same 4 divisions:

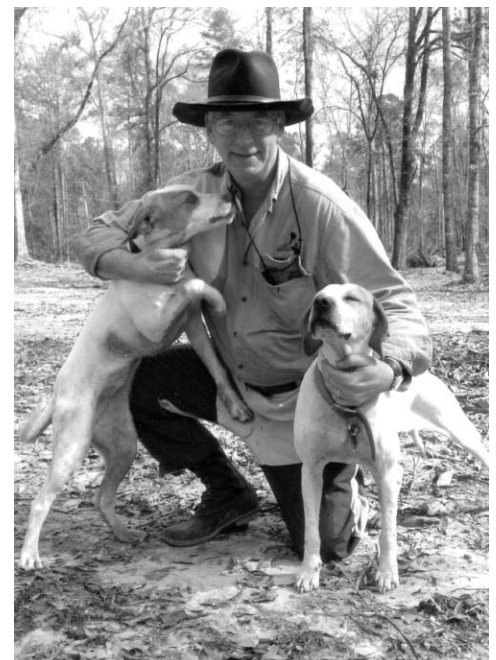
**Puppy (under 1 year)**

# HEY FOLKS

Congratulations to Covey Rise editor, Kim Price who is the newly elected Chairman of the Alabama Quail Council. Kim is also the Chairman of the Southeast Study Group that is scheduled to meet in Auburn and tour the Sehoy Plantation in August 6 – 9, 2006. Your club will make contribution to support the Southeast Study Group.

About this time every year, the word spreads that certain producers of pen-raised quail are running out of birds. There is a solution to this problem. It is spelled, "H-a-b-i-t-a-t".

Bunches of good things are happening for quail and quail habitat.

Quail research is ongoing in the Union Springs area. Federal dollars are available to row-crop farmers for field borders and other habitat improvements to benefit quail. Habitat improvement is being done on private and public land. I ask you, "When are you going to begin work for quail on your property or hunt club?"

Some of you have been thinking about doing some quail habitat work. You probably have ideas of doing some disking, burning, planting or trapping on your property, or asking someone else about doing some work on their property. Perhaps your neighbor may be willing to do some work but needs some direction or ideas about what to do and where to do it. A good place to

start is where you have seen a covey over the past year. Indications are that quail management on the neighbors' property will also help the quail on your property. You gain momentum when the landmass dedicated to quail increases.

Pick 2006 as the year you go forward with your ideas for quail and quail habitat. By beginning your quail habitat work now, you can make that drive to pick up those boxed, pen-raised quail obsolete. Just do it.

Turn Left onto Co. Hwy 16 and go over the hill.

Turn Right onto Co. Hwy 23 and go to the first paved road on the right.

Turn Right onto Co. Road 222 and go to the second house on the left.
